Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to All CME Tracker products, and Coordinator's Choice and governs data collection and usage. The Coordinator's Choice application is an SaaS database application. By using the Coordinator's Choice application, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may choose to provide information to us through Web forms, email or other electronic means. Any personally identifiable information you submit will be used only for the purpose(s) indicated. These may include: (a) registering for an account; (b) sending us an email message. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us.

Sharing Information with Third Parties

Coordinator's Choice does not sell, rent or lease its customer lists or customer data to third parties. At no time do we disclose site usage by individual IP addresses.

Coordinator's Choice will not sell, exchange or otherwise distribute your personally identifiable information without your consent, except to the extent required by law, or with your explicit request and permission.

Coordinator's Choice may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Coordinator's Choice or the site; (b) protect and defend the rights or property of Coordinator's Choice; and/or (c) act under exigent circumstances to protect the personal safety of users of Coordinator's Choice, or the public.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
